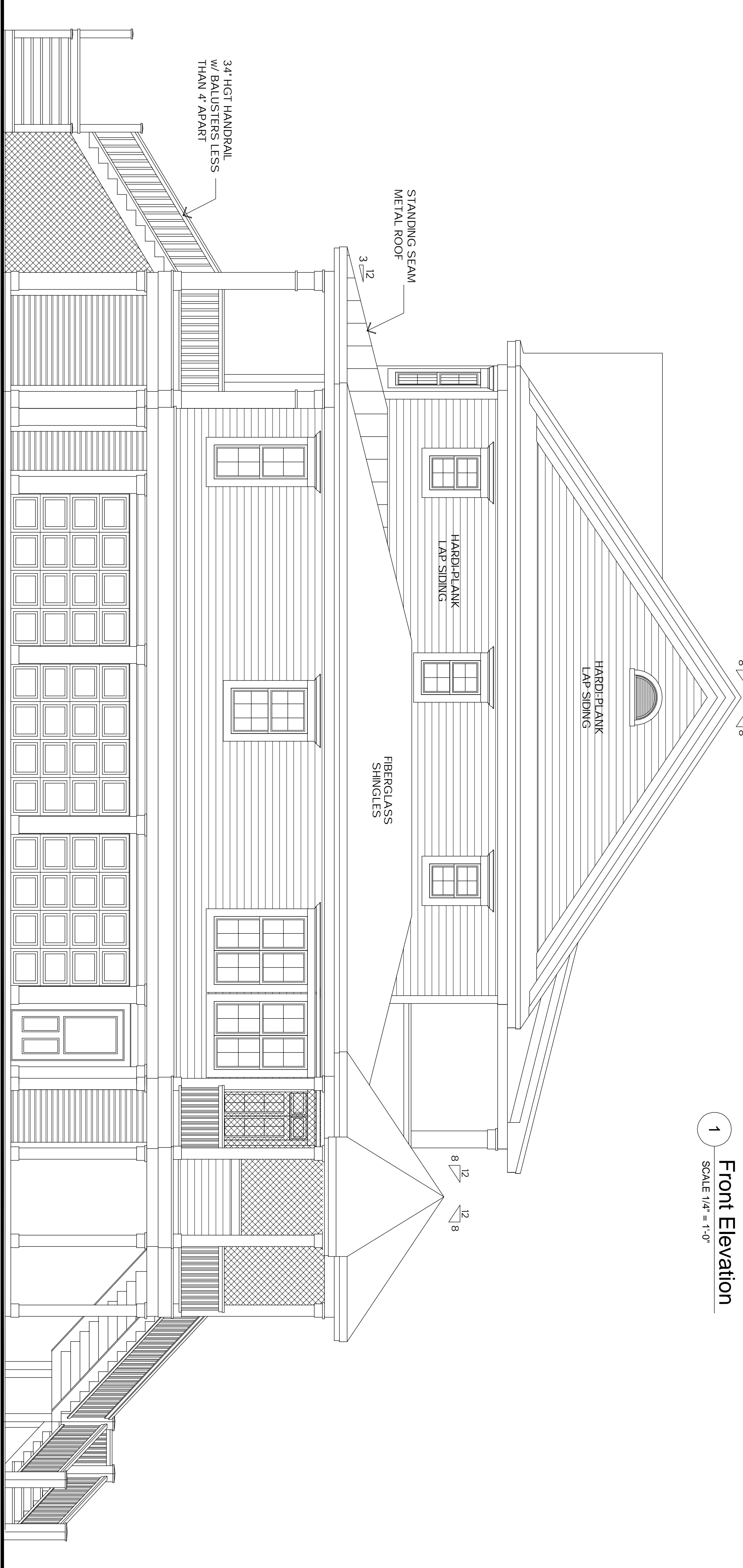


1 Front Elevation

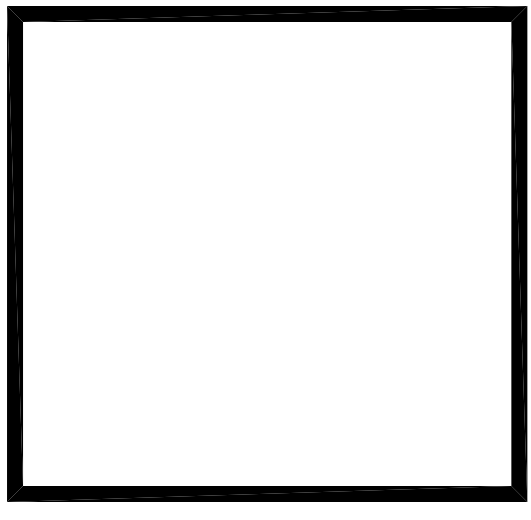

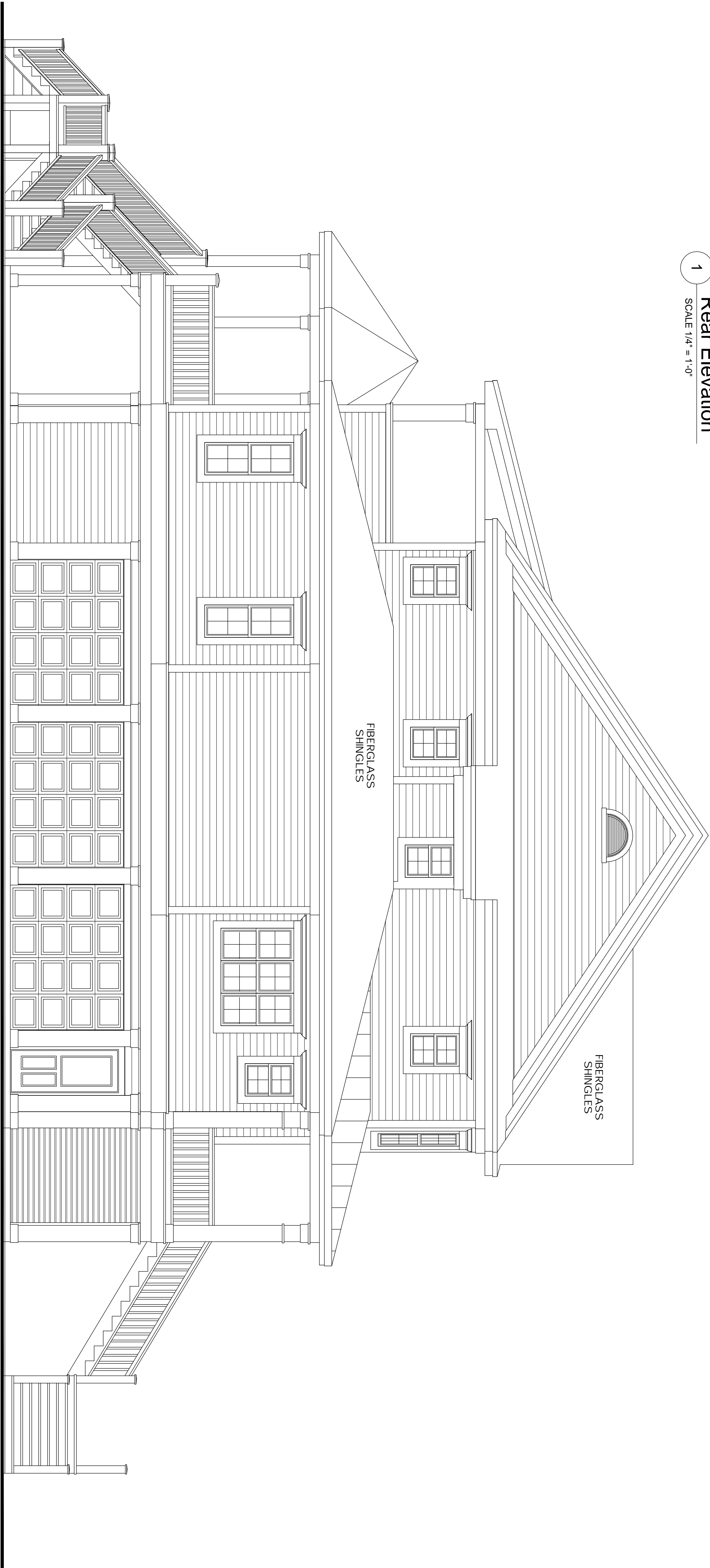

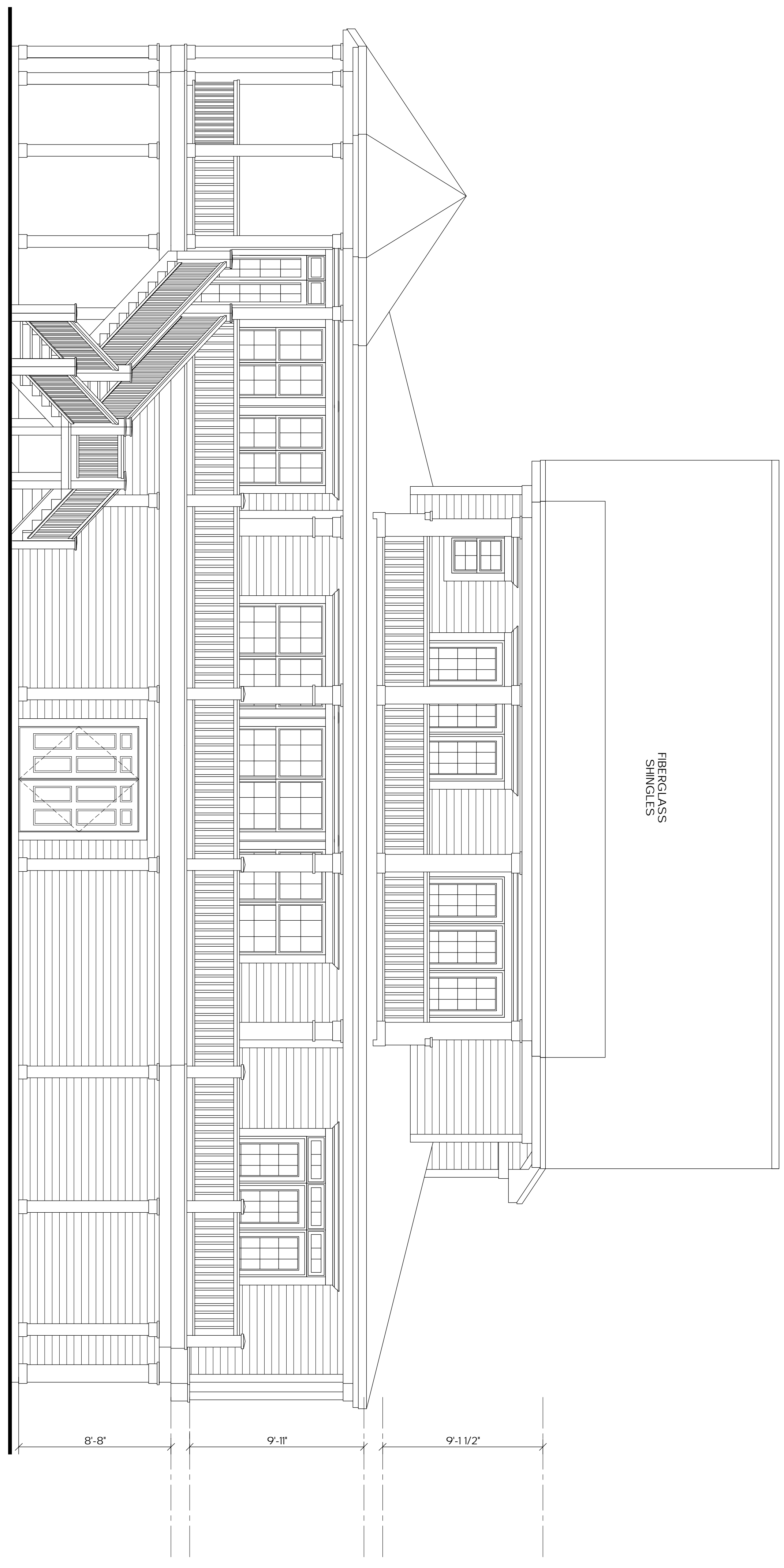
